Background:

The pest known as European Grapevine Moth (EGVM) presents a real and ongoing threat to the agricultural industry, environment and economy of the State of California. Movement of regulated articles and commodities is a recognized channel for the spread of EGVM from established areas to new locations. The EGVM Quarantine Project is a cooperative effort between public entities that are responsible for mitigating the movement of EGVM from regulated areas where the pest is established to new locations.



AGREEMENT:

A. The European Grapevine Moth Quarantine Project, hereafter referred to as the Project, will permit your establishment to self-execute the European Grapevine Moth quarantine regulatory requirements attached as exhibits checked below, inclusive and incorporated into this agreement by reference as if fully set out. EXHIBIT 1269 C- HAULER/TRANSPORTER OF BULK GRAPES FOR CRUSH

Provisions for Intrastate Movement of Bulk Grapes for Crush Produced Inside
the State Interior Quarantine for European Grapevine Moth (EGVM)

Establishment shall move regulated articles *within or from* the area quarantined for EGVM when complying with all of the following:

1. Only transport bulk grapes for crush from a grower* under compliance with the Project.
2. Ensure each shipment of bulk grapes for crush is received by an authorized receiver* under compliance with the Project and/or the receiving County Agricultural Commissioner.

3. Ensure all equipment not containing bulk grapes (bins, barrels, machinery, gondolas, etc.) is thoroughly cleaned of all EGVM host debris and all possible life stages of EGVM prior to leaving the growing premises.
4. The exterior of all vehicles/conveyances used in the transport of shipment must be thoroughly cleaned of all EGVM host debris and all possible life stages of EGVM prior to leaving the growing premises.
5. Transport bulk grapes for crush in a fully enclosed conveyance or the shipment must be completely covered using screens or tarps to prevent the loss of any portion of the load during transit *through a non-quarantine area*.

In contiguous EGVM quarantine areas, bulk grapes may be transported in one of the following ways to prevent spillage of grapes during transit. All trailers, conveyances, containers, etc. must be:

- a. Tightly covered (i.e., tarped, screened, covered by stacked bins, etc.), or
 - b. Filled to 4 inches (***for hand harvested grapes***) or 12 inches (***for machine harvested grapes***) below the rim of the container if grapes have been harvested from a vineyard distanced 200 or more meters from a vineyard with an EGVM detection or where pre-harvest treatments for each generation of EGVM have been applied, or
 - c. Other as specified below (see special instructions).
6. IMMEDIATELY transport bulk grapes for crush from the growing premises to the receiving facility using a continuous direct route, without delay or interruption.
 7. Ensure that the exterior of the vehicle and/or trailer and all equipment (bins, barrels, machinery, etc.) associated with transport is thoroughly cleaned of all host material, debris and all possible life stages of EGVM prior to leaving the receiving facility.
 8. Notify the Project and receiving establishment as soon as possible, but no later than 24 hours in the event of an accident or spillage of the shipment.
 9. Ensure a copy of this EGVM compliance agreement and a copy of this exhibit are inside each vehicle during transit.
 10. Ensure all employees receive training and understand each stipulation of this compliance agreement and exhibit.

Shipments found to be in violation of the above stipulations are subject to being held, rejected, destroyed, or subject to other prescribed actions at the discretion of the EGVM Project.

Failure to comply with stipulations outlined above may result in civil penalties pursuant to California Food and Agricultural Code Section 5705 and/or revocation of this Agreement.

B. In exchange for the Project's promise contained in sub-paragraph "A" above, the Establishment agrees to abide by the following rules and regulations:

1. Handle, process, and/or move regulated articles in accordance with the EGVM quarantine requirements;
2. Follow the Project's instructions regarding the use of all EGVM permits and certificates;
3. Maintain and make such records as the Project requires, accessible for inspection upon reasonable notice by the Project Officer. These records shall be maintained for a period of the later of 2 years or the resolution of any outstanding claims.

C. This agreement becomes effective on signing and shall remain in effect until canceled by either party on 30 days notice to the other at the address of either appearing above. However, the Project may accelerate the notice to immediate for cause, including but not limited to the Establishment's abandonment of the procedures outlined in the attached Exhibit(s).

D. Establishment assumes liability, if any, arising from the manner in which Establishment sells, handles or distributes any regulated host material.

NOTICE: Any signatory or employee of any signatory who violates the terms of this Compliance Agreement may be subject to Civil Penalties pursuant to California Food and Agricultural Code Section 5705.
